Roland questioned Bergtold how this effect our current places where people can eat. Bergtold said they are looking at specialty trucks like BBQ, Mexican, etc. food trucks.

Dale Majewski gave the County Commissioner report. Letters were sent for targeted for gypsy moth and some residents have opted out of having their property sprayed, this will affect how the program will go. He reported that due to Covid there is some relief money coming to the County and the Townships over the next 2 year.
