- **Fire Report:** Fire Chief Tubbs reported this is the report 12/23/2021 1/23/2022 30 Medical / 1 Power Lines/ 1 Misc. / 32 for the month / 350 YTD. Fire Chief Kevin Tubbs reported SJ Conroy is the fire fighter of the year. Mike Athey & Emily Lauer have passed their medical classes. Mike Athey, Dennis Light & Adam Syarto are enrolled in fire fighter classes.
- New air packs have arrived, training will be starting. He reported the Tender is for sale, have a few interested fire departments. The old air packs are for sale

- Byl reported he attended the Broad Band meeting the beginning of January. Garfield Township will
  more than likely not be part of this because of where we are located.
- The Depot pop-up shop; SJ has been cleaning the Depot. Two pop-up shops could go in the Depot. Greg Bergtold sent out an email, targeting businesses that may want seasonal shops or weekend vendors. Construction has been started on the future shops. Byl presented to Jackie from the USDA, to see if the Grant would pay a portion of this cost.
- We are unable to get a new server currently due to a delay with supply.
- Board of Review (BOR) needs another person to replace Tom Radewahn, who is recently deceased. Tom Pirnstill will fill in until we have a replacement for Tom Radewahn.
- The USDA grants has been completed for a possible \$60 thousand towards the cost of the air packs for the Fire Department. Kevin Tubbs did a great job gathering all the information for the grant.
- A portion of the Gray Lake tax assessment has been received so we can pay a portion of this money to PLM for work done in the past.
- On Friday, January 28, 2022, Byl has a court case on Miles St, for a clean-up order.
- The Transfer Station is down \$13,000.00 in costs from last year.
